#### ELECTION OF OFFICERS

The following slate was approved effective January 1, 1996.

#### SANCTION/RECOGNITION REPORT

The Silver Creek OW results had been received leaving STAR's ECC June 1995 meet the only event without acceptable meet results, the final step in complying with USMS and NIAG requirements.

A resolution offered by Dan Kornblatt of Binghamton and passed unanimously determined:

- (1) NIAG LMSC hereby grants a two-week grace period to resubmit results.
- (2) Failure to comply will result in denial of sanctions and recognitions for a period of one year (June 1995 to June 1996).
- (3) Betty Barry was directed to notify Dick Boehm of the decision with a copy to Gene Donner.

#### CALENDAR 1995/1996 SEASON

- 1) All requests for sanctions and recognitions for the 1995/1996 season were considered. The attached calendar indicates the status of each request. It was decided to finalize the spring calendar after the dates are set for the 1996 Colonies Zone SC Championships. The bid will be awarded in late September at the national convention.
- (2) As a result of a problem with results of the June ECC meet, all requests by Gene Donner for the STAR/ECC Pool were left pending.

#### SWIMMER SURCHARGE

By unanimous resolution it was decided by those present that:

- 1) A swimmer surcharge of two dollars (\$2) per swimmer will be charged to the host of any recognized event.
- 2) There will be no swimmer surcharge for sanctioned events.

#### MASTERS vs NON-MASTERS HOSTS

Consideration of the "Masters" host versus "non-Masters" host criteria was tabled until a later date.
