## NIAGARA DISTRICT MASTERS SWIMMING ---- ANNUAL MEETING

February 13, 2011, Canandaigua, NY

Call to Order at 1:50PM Chairman Brophy.

**Present**: Neil Brophy (chairman), Lynn Fuller (treasurer), Amy Johnson (secretary), John Pilger (registrar), Greg Danner (webmaster, records, top10), Lorie Rick (fitness/coaches), George McVey (officials), Rauni English(postal rep), Ken Koppenhaver (past chair).

**OLD BUSINESS** – None presented.

## **NEW BUSINESS and REPORTS**

- 1. **Registrar** John Pilger reported 415 members as of today which is about 50 more than last year. This increase is probably due to the three USMS mailings prompting renewal.
  - On Line Registration is used by 90% of our members.
  - 141 have not renewed and Webmaster Danner will email them a reminder with a link to the USMS registration page.
  - "Unattached" swimmers Niagara District has two registered clubs, Niagara and BUMS. Unattached swimmers are free to join any USMS club of their choice without a waiting period. This option can be used by swimmers wishing to declare and swim with a team of their choice especially for national competitions.
  - Pilger wondered how many of our 415 members actually compete. G. Danner will try to answer this by cross referencing meet entry lists with the membership file.
- 2. **Treasurer** Lynn Fuller presented the <u>2010 Financial Report</u>. He sends monthly statements to the Chairman and Secretary for review as required by USMS procedures
  - The Treasurer and Chairman recommended that the District continue the \$500 meet bonus. Motion (L. Fuller, second L. Rick) Any swim group in the Niagara District that runs a Masters meet, sanctioned or recognized by Niagara District Masters Swimming from 9/1/2009 onward, will get \$500 upon the timely submission of meet results, pool certification, and observer's report as specified in the sanction instructions. Motion passed.
- 3. **Secretary** A. Johnson is resigning. Chair Brophy thanked her for serving since 1996.
  - The office file will be passed on today and includes the final report on the 1994 LC Nationals in Buffalo and copies of "The Gazette" newsletter from 1989 with a back-up disk. G.
    McVey said that he may have earlier newsletters to add and have posted on the web site.
  - Ann Marie Crye has agreed to be Secretary.
- 4. **Records -** Greg Danner has added the <u>Split Notification Form</u> to the Sanctions page of the Niagara web site. Danner recommended that it be available at meets and that copies be included in the equipment/officials box.
- **5. Top10** Greg Danner has chaired following the resignation of Dana Gianniny.
  - The Pool Length Certification file is being transferred to Danner. Only one Niagara pool certification is on file in the USMS data base.
  - The Top 10 program works well and generates a final report that Danner sends to USMS.

- **6. Webmaster** Danner posts materials as submitted and solicits input from the Chairman and Board members before posting anything questionable.
  - Chair Brophy stated that our web site functions as a newsletter. Danner can send email alerts to members when a new or important item is posted.
  - Brophy congratulated Webmaster Danner on our new and improved web site and the Board expressed their appreciation and gratitude for his good work.

## 7. Chairman

- Frequency of meets We have averaged one meet per month which seems to work well and our policy is to give the sponsor of a well run meet first choice for that month in the following year. The meeting decided not to vote any restriction but to leave scheduling up to the Chairman's discretion.
- Chair Brophy presented nominees to fill vacant positions.
  - a) Rauni English as Postal Representative, seconded by L. Rick. Approved.
  - **b**) Ann Marie Crye as Secretary, seconded by G. McVey. Approved.
  - c) Greg Danner as Top10, seconded by K Koppenhaver. Approved.

## **OTHER**

- 1. Postal Events R. English puts relays together after individual results are posted. Because members of a team or work out group may want be together, she will notify swimmers that she plans to place them on a relay. To benefit Niagara swimmers she suggested that the district could rent a LC pool for the long distance postal events.
- **2. Swim Clinic** G. Danner and L. Rick will work on a clinic possibly at Brockport State College with Jack Stover, head swimming and diving coach.
- **3. Awards** L. Rick introduced the idea of developing an award or recognition for a Niagara swimmer.
  - <u>Motion</u> (N. Brophy, second L. Fuller) L. Rick shall head a committee to establish criteria for nomination to a Niagara District Masters Swimming Hall of Fame. <u>Motion passed.</u>
- **4. Officials** McVey reported that we need officials and requested that a "want ad" to recruit new people be posted on the web. Chair Brophy will get more watches for the equipment box (need 18).
